A Few Important Terms To Help Get Your Conversation Started:

SOCIAL SECURITY DISABILITY **INSURANCE (SSDI)** -

Benefits for people considered with a disability by Social Security Administration's criteria. who have worked enough to qualify for benefits.

TICKET TO WORK –

Incentive program through Social Security Administration to encourage beneficiaries of SSDI and SSI to attempt to return to work and provides additional protections to disability benefits. https://choosework.ssa.gov/index.html

SSI –

Federal income supplement program that provides cash to meet basic needs for food, clothing, and shelter to help aged, blind, and disabled people who have little or no income.

EARNINGS -

earnings or earned income is money from working. Gross earnings is the amount of money from working before taxes is deduct.

RESOURCES –

Anything own, ones' assets. For example – cash, cars, stocks, bank account, or other property own that one can use to support oneself.

MEDICARE –

Health coverage provided

by the Federal program for

recipients of SSDI and other

SSA benefits except SSI.

INCOME –

Income includes cash. checks. and other things you get that can be used for food or shelter.

MEDICAID –

Public health insurance program funded by Federal and State. Coverage provided to adults with low income, pregnant women, children, elderly adults, blind, and or people with disabilities.

VOCATIONAL

REHABILITATION (VR) -

VR is a U.S. Department of Education funded program to help people with functional, psychological, developmental, cognitive and emotional impairments or health disabilities to find, get, keep work or return to work. http://www.rehabworks. org/customers.shtml

EMPLOYMENT NETWORK – A provider, under contract with Social Security, delivers free career counseling, job placement, and ongoing employment supports and services to Social Security

disabilities beneficiaries.

IRWE-

Impairment related work expenses are costs associated with items and services a recipient of SSDI and or SSI need to be used for work.

PROTECTION AND ADVOCACY FOR BENEFICIARIES OF SOCIAL SECURITY (PABSS) -

Provides legal support, advocacy and information to help SSI and or SSDI beneficiaries with disabilityrelated employment issues and concerns.
